Goal Two - Advocacy and Lobbying

Represent North Dakota economic development interests in public policy matters and legislative affairs.

A. Engage with Legislators and the Governor's Office

Actively collaborate with legislators, partners, and the governor's office to develop and advocate for policies that enhance North Dakota's economy and quality of life. Monitor and update on 2023—2024 Interim Studies

B. Community Success Stories

Highlight success stories within communities to create social buzz and connect with stakeholders and opinion leaders – distribute to legislators throughout next session

C. Educate Legislators

Seek methods for educating legislators about the importance of economic development, including social events, lobby efforts and training sessions

- Investigate/Create a Legislative Action Team (EDND members, past or present legislatures, etc.)
 - o Develop a toolkit or informational package to outline economic impact of development incentives
 - O Look into training sessions for new developers to improve their advocacy and communication skills
- Identify legislative champions to help connect developers to policy



Goal Three - Association Leadership

Serve as the voice of the economic development community through outreach and association development activities.

A. Membership Recruitment

Continue the recruitment plan to attract active (professional) members, with a focus on new upcoming professionals and small organizations

Expand the association's membership base by offering associate memberships to other entities that support economic development

- C. Collaboration with Partners

Explore opportunities for collaboration with organizations like GNDC, League of Cities, Association of Counties and the Economic Development Foundation, especially in publications, conferences and meetings.

D. Leadership Development

Encourage economic developers to apply for appointed positions and engage emerging leaders in association activities
